TITLE: Resolution Appointing the Law Firm of Nabors Giblin & Nickerson, P.A., as

Special Counsel, to Represent the City of Fort Lauderdale in Connection with the Unsolicited Proposal and Project Submitted by IDE Technologies/Ridgewood Infrastructure, or if Necessary any Subsequent-Ranked Proposers, for the Design, Construction, Operation, and Maintenance of a New Water Treatment Plant and Associated Systems for the City's Water Utility, Including any Associated Regulatory and

Contractual Matters - (Commission Districts 1, 2, 3 and 4)

Recommendation

Due to the complexity and breadth of issues involved in proceeding forward with significant changes to, and the development of, the City's proposed new water treatment plant, system management, and maintenance, through a public-private partnership, the City Attorney recommends that the City Commission adopt a resolution appointing Nabors Giblin & Nickerson, P.A., as special counsel to represent the City of Fort Lauderdale in connection with the unsolicited proposal and project submitted by IDE Technologies/Ridgewood Infrastructure, or if necessary any subsequent-ranked proposers, for the design, construction, operation, and maintenance of a new water treatment plant and associated systems for the City's water utility, including any associated regulatory and contractual matters.

Background

Section 4.10 of the Charter of the City of Fort Lauderdale, Florida, provides, in part, that "[t]he city commission may, by resolution, authorize one (1) or more special counsel to be retained for the purpose of performing such legal duties as may be prescribed by said resolution. Each such resolution shall further prescribe the compensation to be paid the special counsel."

Nabors Giblin & Nickerson, P.A., who has represented the City on other varied legal matters, has helped created some of the State of Florida's most innovative P3 projects, including establishing the relevant law in related areas. From utilities, transportation improvements, multi-purpose developments, convention and hotel facilities, to sports facilities, Nabors Giblin & Nickerson, P.A. is well experienced in representing public
