TITLE: Motion Approving the Acceptance of a Modular Decontamination Kit (MDK)

from the Broward County Healthcare Coalition in the amount of \$7,700 -

(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a motion authorizing the City Manager to accept a donation of a Modular Decontamination Kit (MDK) for Fire Rescue's Hazardous Materials Team (HazMat) and to execute any documents required to accept the equipment between Broward County Healthcare Coalition and the City of Fort Lauderdale.

Background

The Broward County Healthcare Coalition (BCHC) has funded a grant to enhance participating agencies (4 Hazardous Materials Team Fire Rescue agencies) capabilities by distributing "Modular Decontamination" kits. As a result of the strong partnership between the Broward County Healthcare Coalition and the special operations community in Broward County, the HazMat's for Fort Lauderdale, Sunrise, Hollywood, and Broward Sherriff's Office Fire Rescue all received "Modular Decontamination" kits. These kits include a variety of specialty equipment such as FiberTect wipes, FiberTect Mitts, Reactive Skin Decontamination Lotion, and Tactical sprayer. Paired with the training that each HazMat member is required to obtain, this equipment fills a void in our response profile and further enhances the capability of each HazMat Team in Broward County.

The goal of the MDK is to enhance the agency's ability to respond to a wide range of emergencies. The MDK is a decon kit used to decontaminate responders, patients, and or surfaces exposed to various organophosphate, 4th generation nerve agents, and synthetic opioid compounds. The MDK includes equipment to treat 50-150 contaminated patients depending on the severity of the incident.

Fort Lauderdale Fire Rescue's Hazardous Materials Team (HazMat) was included in the Broward County Healthcare Coalition's grant as we are an active member of the coalition. Fort Lauderdale Fire Rescue will receive a kit containing the following:

- (1) Packing Guide
- (1) 36' x 36" Shuffle Pit

- (50) FiberTect 6" x 12" wipes
- (50) FiberTect 12" x 12" wipes
- (2) S-Cut 501s
- (50) FiberTect Mitts (25 on top, 25 on bottom)
- (10) 21ml Reactive Skin Decontamination Lotion (RSDL) Kits
- (3) 36" x 36" FiberTect Shuffle Pit Liners
- (10) 22 oz. Dahlgren Decon Ready-to-Use Configurations
- (2) Tactical Sprayers

Resource Impact

This action will result in a positive impact to the City. The value of the donated MDK is \$7,700.
