BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

WHEREAS, the Participating Agencies entered into the MOU effective on October 1, 2017;

WHEREAS, the participating agencies wish to include Broward County as a Participating Agency; and

WHEREAS, the Department of Justice (DOJ) has requested the parties update the MOU to reflect the actual grant amount awards received by each jurisdiction under the JAG in order to exactly match their grant budgets and sub-grant agreements and so that the MOU reflects the total grant amount; and

WHEREAS, the participating agencies agree to amend certain terms and conditions of the MOU.

WITNESSETH:

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth the participating agencies agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.

2. The terms and conditions contained within the MOU between the Participating Agencies, effective October 1, 2017, a copy of which is attached hereto and made a part hereof as Exhibit "A," shall remain in full force and effect except as specifically amended herein below.

3. The Participating Agencies hereto agree to add Broward County as a Participating Agency.
