TITLE:Motion Approving Increase in Funds for Sound, Stage & Lighting Services- BFAV LLC - \$228,175 - (Commission Districts 1, 2, 3 and 4)

# **Recommendation**

Staff recommends the City Commission approve an increase in funds to Bid Contract No. 12081-883 for the purchase of sound, stage and lighting services from BFAV LLC dba All On Stage Productions in the amount of \$228,175.

### **Background**

On May 15, 2018, the City awarded Bid Contract No. 12081-883 to All On Stage Productions, Inc., for Sound, Stage and Lighting services in the amount of \$302,900 (CAM 18-0362). This is a one-year contract with three, one-year options to renew, contingent upon appropriation of funds.

On February 15, 2022, the City approved an assignment to contract from All On Stage Productions, Inc. to BFAV LLC (CAM 22-0190).

The City administratively extended the contract termination date by 120 days to prepare and/or award a competitive solicitation. The Department is requesting additional funding in the amount of \$228,175 to cover additional services through the contract extension date of September 14, 2022.
