**TITLE**: Motion Authorizing Additional Funding in the Amount of \$11,300,000 for the

Parks Bond and Parks Master Plan Design and Implementation Services Agreement – AECOM Technical Services, Inc. - \$11,300,000

(Commission Districts 1, 2, 3 and 4)

#### Recommendation

Staff recommends the City Commission authorize additional funding for the Parks Bond and Parks Master Plan Design and Implementation Services Agreement with AECOM Technical Services, Inc. (AECOM) by \$11,300,000, amending the total estimated value for services from \$4,000,000 to \$15,300,000.

#### **Background**

On May 5, 2020, the City Commission awarded the Parks Bond and Parks Master Plan Design and Implementation Services contract (RFQ #12308-296) to AECOM with an estimated total value of \$4,000,000 based upon the 2020 FY impact. The agreement is for design and program management services for the City's \$200 Million Dollars park bond improvement program and administered through task orders for services including, but not limited to, public outreach, design coordination, and program management services. The task orders are funded from the authorized spending cap.

The initial \$4,000,000 value served to initiate the park bond program management, facilitate the public outreach, and provide design direction for the individual park projects. The agreement was awarded to AECOM managed by City-authorized individual task orders with the understanding that additional funding requests would follow as the program evolved and design work began.

This additional funding is needed to fund task orders for design services remaining in Phase 1 projects and Phase 2 projects. The task order values will be negotiated based upon the agreed upon hourly rates in the AECOM agreement. The funding is also needed to fund program management and Construction, Engineering, and Inspection (CEI) services for Phase 1 and Phase 2 projects, and design and construction related services for the signature park projects.

### **Resource Impact**

There will be a fiscal year impact to the City in the amount of \$11,300,000 for this cap increase. Funds for this increase in the amount of \$11,300,000 are available in the FY 2022 Community Investment Plan in the accounts listed below.
