Treatment Plant Capacity Analysis Report and Renewal/Replacement Report Updates - CDM Smith, Inc. - \$34,875 - (Commission Districts 1, 2,

3 and 4)

Recommendation

Staff recommends the City Commission approve Task Order No. 3, in the amount of \$34,875 to CDM Smith, Inc., to prepare a report to analyze the capacity of the George T. Lohmeyer Wastewater Treatment Plant (GTL) and to prepare an annual schedule that projects the renewal and replacement costs anticipated over the next 20-years for equipment at the plant.

Background

The City of Fort Lauderdale's agreements with the large users of the Central Regional Wastewater System include the requirement that the City prepare an annual schedule that projects facility renewal and replacement costs over a 20-year span. This schedule provides an estimate of funding for anticipated renewal and replacement expenditures for the Central Regional Wastewater Treatment facilities. CDM Smith, Inc., a professional engineering consulting firm, is currently under contract with the City, pursuant to CCNA - Professional Services Library, Continuing Services Contract (CAM 22-0217), RFQ No. 12464-416-3-7 and has the appropriate expertise to perform the required work.

Approval of this Task Order will allow the City to engage the services of this consultant to determine the facility's renewal and replacement costs over a 20-year span and prepare a capacity analysis report of the treatment facility.

This Task Order will bring the contract amount over the initial Commission threshold, and as such, is being presented for approval.

Resource Impact

There is a fiscal impact to the City in the amount of \$34,875 for this Task Order. Funds for this Task Order, in the amount of \$34,875, are available in the FY 2022 Operating Budget in the account(s) listed below.
