The attached draft ordinance was proposed by D'Wayne, Assistant City Attorney, to revise the boundaries and incorporate the District into the City's ordinances. Chapter 189 – Special Districts of the Florida Statutes is used as the basis for this incorporation, rather Chapter 298 for Water Management Districts, because Water Management Districts may no longer be created under that Statute according to the Florida rule.

Chairman Rames had proposed a more focused verbiage be added to the ordinance as indicated in the attached email. A

A discussion on the specific details ensued concerning the focused efforts proposed.

- b. Chairman Rames proposed to postpone the adoption of the ordinance until further discussions of the details were resolved. Larry reminded the board that they could meet individually with D'Wayne and resolve any questions they had but should avoid meeting collectively due to Sunshine laws.

Chairman Rames said he would pursue a meeting later. Commissioner Sorensen said he would also follow up with D'Wayne.

Final agreement of the ordinance language should be obtained prior to the LIWMD June 20<sup>st</sup> meeting.

The ordinance and any revisions should be completed and available for adoption for an August Commission meeting.
