TITLE: Motion Approving Not for Profit Grant Participation Agreement with the Fort
Lauderdale Historical Society, Inc. - \$38,747.26 -
(Commission District 2)

Recommendation

Staff recommends the City Commission approve the Not-for-Profit Grant Participation Agreement with the Fort Lauderdale Historical Society, Inc., a Florida Not For Profit Corporation (FLHS.) located at 219 SW 2nd Ave, Fort Lauderdale, FL 33301. The grant agreement, in the amount of \$38,747.26, is for repairs to maintain and improve the City buildings in the historical district.

Background

On January 28, 2001, the City entered into a fifty (50) year lease agreement with FLHS which includes The New River Inn, King-Cromartie House, Philemon Bryan House, School House Replica and Fort Lauderdale Historical Society Building. Fort Lauderdale Historical Society, Inc. serves a municipal public purpose by acting in an integral position in the educational, cultural and historical life of the City of Fort Lauderdale and to serve as an important resource as a heritage tourist destination within the Riverwalk Arts and Entertainment District.

During the Covid-19 pandemic, FLHS suffered significant revenue losses due to closures and restrictions. FLHS is requesting reimbursement for expenses incurred to upkeep its buildings during that time. The City shall contribute to FLHS \$38,747.26 as a one-time payment to be used solely for costs associated with the repair and maintenance of the Historical Buildings during FY2021.

Each benefiting not-for-profit organization that receives funding from the City is required to execute a participation agreement with the City that provides for the funding amount and terms of the contribution, scope of services, and standards of performance.

Resource Impact

There is a fiscal impact to the General Fund in the amount of \$38,747.26. Funds for this agreement are budgeted in the FY 2022 Budget in the account listed below.

This item is contingent upon the approval of the Consolidated Budget Amendment CAM 22-0261.
