- Shiff Construction & Development, Inc. - \$9,098,926.87 - (Commission

#### Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with Shiff Construction & Development, Inc., for DC Alexander Park Improvement Project in the amount of \$9,098,926.87.

#### **Background**

The purpose of the proposed project is to revitalize and create a 1.2-acre oceanfront park that is both vibrant and uniquely branded for local residents, tourists, and citizens of Fort Lauderdale. Key improvements include signature playground installation, elevated viewing platform overlooking the ocean, elevated ramp/walkway with play elements incorporated into the grade changes, terraced walls with landscape beautification, decorative metal canopy/trellis, and public restroom.

The work to be accomplished under this contract includes, but is not limited to, site clearing and demolition, tree relocations, landscaping, pedestrian lighting and site furnishings, pavers, decorative concrete, structural concrete and masonry, deep foundations, waterproofing, epoxy flooring, plumbing, bathroom fixtures, HVAC, site electrical, architectural/decorative metal, playground installation, mass site grading, site civil utilities, streetscape improvements along NE 5th Street, and sidewalk and landscape improvements along North Bound and South-Bound State Road A1A.

On January 4, 2022, the Procurement Services Division issued Invitation to Bid No. 12616-423. The City received the following three (3) bids in response to the solicitation, which were opened on February 28, 2022:

- 1. Home Express Corp.
- 2. Shiff Construction and Development, Inc.
- 3. West Construction, Inc.

All bids were reviewed for compliance with the solicitation specifications and none of the three (3) vendors listed their status as a Disadvantaged Business Enterprise (DBE). During the evaluation process, Home Express Corp. withdrew its bid and confirmed its pricing for three (3) line items was incorrect and should have been higher.

As such, the second lowest bid (West Construction Inc.) was then considered for award. However, City staff discovered that in 2013, the City of Fort Lauderdale terminated its contract with West Construction. A Settlement Agreement was entered and agreed upon between the City and the bidder. Furthermore in 2021, Collier County and West Construction had a similar situation and entered into a Settlement Agreement. West Construction failed to disclose these prior acts and settlements which relate to the quality of its performance on similar projects. For these reasons, West Construction Inc. was deemed non-responsible.

Therefore, since Shiff Construction & Development Inc. met all the solicitation requirements, the firm was deemed the most responsive, and responsible bidder. Additionally, the award amount of \$9,098,926.87 includes a voluntary price reduction secured by the Procurement Services Division from Shiff Construction & Development Inc. of \$91,150.78.

## **Resource Impact**

There will be a fiscal impact to the City in the amount of \$9,098,926.87 for the contract award (with allowances included) and \$503,582.35 for estimated project management fees, for a total cost of \$9,602,509.22. Funds for proposed project in the amount of \$9,602,150.22 are available in the FY 2022 Community Investment Plan in the accounts listed below.
