# NARRATIVE ON PARKING REDUCTION & EXEMPTION CRITERIA TO ACCOMPANY APPLICATION FOR SITE PLAN LEVEL IV

#### ULDR Section 47-20.3.A.5, Parking Reduction and Exemption Criteria

### 1. General Information

The City of Fort Lauderdale ("Owner") owns the property located at 1300 W Broward Boulevard and 1201-1205 SW 1<sup>st</sup> Street 1 - 8 ("Property). The Property is located within the Sailboat Bend Historic District. The Owner is requesting to demolish buildings on the Property and to build a new Police Headquarters and secured parking garage.

## 2. ULDR Requirements for Parking Reduction & Exemption Criteria

### **RESPONSE:**

The proposed parking (577 spaces) can accommodate the current demand (371) as well as the future (146) FLPD staff. The required parking spaces for the Police Facility is 1 per 250 gross square feet, which would require 760 spaces. We would like to pursue a parking reduction based on the current and future demand of the proposed facility.

The current design for the Fort Lauderdale Police Headquarters has a current workstation and office count of 371 positions. The facility will have the capability to accommodate future positions for FLPD staff in the amount of 146. See Table 1 below.

The proposed secured parking garage can accommodate 358 vehicles with an additional 30 visitor surface parking spaces and 28 secured surface parking spaces for Other Jurisdiction (14 spaces, these are reserved parking spaces for other police departments coming to the facility for training) and Confiscated vehicles (14 spaces). There are also 64 specialty vehicle parking spaces and 30 motorcycle parking spaces on the ground floor of the parking garage. There are 161 existing surface parking spaces on the northwest portion of the site that will be maintained for future parking. See Table 2 below.
