TITLE: Motion Approving an Agreement for the Purchase of Liquid Chlorine in Rail

Cars - Allied Universal Corporation - \$1,590,000 - (Commission Districts 1,

2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a one-year agreement, in substantially the form attached, for the purchase of Liquid Chlorine in rail cars to Allied Universal Corporation for an initial one (1) year term amount of \$1,590,000, and authorize the City Manager to approve three (3), one-year renewal options, in the estimated annual amount of \$1,590,000, for a potential total contract amount of \$6,360,000, contingent upon appropriation of funds.

Background

During the water treatment process, chlorine is added to the finished water which provides a disinfectant residual that is sustained throughout the distribution system. The disinfectant residual must be maintained as per the Florida Department of Health and Florida Department of Environmental Protection regulations.

On July 5, 2022, the Procurement Services Division issued Invitation to Bid Number 12707-322 and received two responses, one of which was a no bid. The bid provided by Allied Universal Corporation meet the bid requirements and is the low, responsive, and responsible bidder. Neither of the two (2) vendors indicated their status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$240,000 for this purchase. Current year funds are available in the accounts listed in the chart below. Future years' expenditures are contingent upon approval and appropriation of the annual budget.
