NOTICE OF FUNDING AVAILABILITY (NOFA) STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) FUNDS PROGRAM YEAR (PY) 2022-2023

PLEASE TAKE NOTICE that the City of Fort Lauderdale has received One Million Seven Hundred Eighty-Two Thousand Two Hundred Fifty-Seven Dollars and Zero Cents (\$1,782,257.00) SHIP funds for PY2022-2023. These funds must be used in accordance with 2022-2025 approved Local Housing Assistance Plan (LHAP). SHIP rules in Florida Administrative Code 67-37.005 requires that funds be advertised at least thirty (30) days prior to taking applications unless funds are not available due to a waiting list. Applications may be submitted 30 days after this notification for each strategy as listed below, beginning July 15, 2022, through and including August 15, 2022, to the City of Fort Lauderdale, Housing & Community Development Division, 914 Sistrunk Blvd. Suite #103, Fort Lauderdale, Florida 33311, and will be processed on a first qualified, first served basis.

The City proposes to use the funds for the following strategies:

Project and activities will be prioritized based on the following criteria, unless otherwise stated.

- A focused use of SHIP funds will be made to assist applicants in the target area eEast of I-95 and West of Northwest 9th Avenue, South of Sunrise Boulevard and North Oof Broward Boulevard.
- 2. Elderly and special needs persons.
- Development of new affordable housing and the preservation of existing affordable rental housing through out the City.
