- TITLE: Motion Approving Agreement for Southeast Isles Seawall Replacements and Stormwater Improvements – Poseidon Dredge & Marine, Inc. – \$2,954,062 – (Commission Districts 2 and 4)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the Southeast Isles Seawall Replacements and Stormwater Improvements Project with Poseidon Dredge & Marine, Inc. in the amount of \$2,954,062.

Background

This project is for the replacement of approximately 790 linear feet of existing seawalls (total combined length) along East Las Olas Blvd. and along SE 10th St. The seawalls are numbers 12, 13, 14, 30, and 36 as identified in the City's 2018 Seawall Masterplan. The new seawalls will be constructed of corrosion-resistant steel sheet-piles with a concrete cap. The new top of wall elevation will be 5.0' NAVD88, per the new seawall ordinance. Additionally, all required ancillary stormwater infrastructure improvements will be completed concurrently to ensure surface water runoff is properly drained from the public right-of-way, through the new seawall, and into the adjacent canals.

On April 28, 2022, the Procurement Services Division issued Invitation to Bid No. 12678-923. The City received the following seven (7) bids in response to the solicitation, which were opened on June 16, 2022:

- 1. Poseidon Dredge & Marine, Inc.
- 2. Ebsary Foundation Co.
- 3. Kelly Brothers, Inc.
- 4. Custom Built Marine Construction, Inc.
- 5. Continental Heavy Civil Corp.
- 6. David Mancini and Sons, Inc.
- 7. Kiewitt Water Facilities South Co.

All bids were reviewed for compliance with the solicitation specifications and none of the seven (7) vendors listed its status as a Disadvantaged Business Enterprise (DBE). The

bid submitted by Poseidon Dredge & Marine, Inc. has met all specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid.

Resource Impact

There is a fiscal impact to the City in the amount of \$2,954,062 for the contract award, with allowances included, \$491,448 for construction engineering and inspection (CEI) services, and \$100,000 for in-house project management fees for a total cost of \$3,545,510. Funds for this Agreement, in the amount of \$2,602,635, are available in the FY 2022 Community Investment Plan in the accounts listed below, with \$942,875 contingent upon approval by the City Commission and appropriation of the consolidated budget amendment CAM #22-0262.
