## **RESOLUTION NO. 22-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA, ADOPTING THE TENTATIVE BUDGET OF \$176,834 FOR THE SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT FOR FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023.

WHEREAS, pursuant to applicable provisions of law, the Board of Directors for the Sunrise Key Neighborhood Improvement District has prepared a tentative budget for the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2022 and ending September 30, 2023; and

WHEREAS, a "Notice of Proposed Millage Rate and Tentative Budget Hearings" has been published as required in Section 200.065, Florida Statutes, advising the public that a public hearing on the proposed millage rate and tentative budget would be held on September 6, 2022 at 5:01 P.M., or as soon thereafter as possible, in the City Commission Chambers at City Hall, 100 North Andrews Avenue, Fort Lauderdale, Florida; and

WHEREAS, said public hearing has been held as stated above and comments from the public concerning said proposed millage rate and tentative budget have been heard and considered; and

WHEREAS, as set forth during the tentative budget hearing, the appropriations and revenue estimate for the Budget for the Sunrise Key Neighborhood Improvement District fiscal year starting October 1, 2022 and ending September 30, 2023 is in the amount of \$176,834; and

WHEREAS, it is the desire of the City Commission of the City of Fort Lauderdale to adopt a tentative budget for the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2022 and ending September 30, 2023;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the tentative budget attached and incorporated herein as Exhibit A is hereby adopted and approved as the tentative budget of the Sunrise Key Neighborhood Improvement District for the fiscal period beginning October 1, 2022 and ending September 30, 2023.

## MINUTES SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT May 11, 2022

Ray Parker called the Zoom meeting to order at 1:03 p.m. Directors also present at the meeting were Richard Campillo, Cliff Berry, Tom Walter, and Mark Grant. Milton Jones and Caldwell Cooper were not in attendance. Also present at the meeting were a number of homeowners who attended the meeting via Zoom. Ray Parker determined a quorum of Directors were present.

Ray Parker asked that the minutes of the meeting of June 23, 2021 be approved and ask that the reading of the minutes be waived since all Directors have previously received the minutes. Upon motion duly made and seconded, the minutes were approved as presented.

Ray Parker and Mark Grant discussed the proposed budget for 2023. They discussed the actual expenditures compared to the budgeted expenditures during the current year and the possibility of a rate increase for the police patrol and the increase insurance cost. It was determined that the police patrol could be increased to 135 hours per month plus the hours Captain Scelfo provided.

After a full discussion, Ray Parker made a motion that the budget for 2023 be set at the same \$137,000.00 that was the budget for 2022 and that the millage rate for 2023 continue to be set at 1.0 mil. Such motion was seconded and after further discussion, the motion was unanimously approved. The following is the approved budget for 2023:

Ray Parker then discussed the prohibition in the Ordinance that created the District; such prohibition being that the District could not address the improvement of utilities. Mark Grant pointed out that the state statute did not require such a prohibition but that such prohibition was up to the City that enacted the Ordinance. A discussion followed regarding the need to ask the City to amend the Ordinance to remove the prohibition which would allow the District to take various actions to improve utilities, particularly the undergrounding of overhead utility lines. It was agreed that Ray Parker and Mark Grant should approach Commissioner Steve Glassman to ask for his assistance in having such an amendment adopted by the City Commission.

There being no further business to come before the Board, it was adjourned at 1:50p.m.
