**TITLE:** Resolution Adopting the Fiscal Year 2023 Tentative Millage Rate (4.1193)  
for the City of Fort Lauderdale - **(Commission Districts 1, 2, 3 and 4)**

---

**Recommendation**

Staff recommends the City Commission hold a Public Hearing to review the proposed millage rates and adopt a resolution approving the tentative millage rate of 4.1193 and the tentative debt service millage of 0.2833 for the City of Fort Lauderdale for Fiscal Year (FY) 2023 beginning October 1, 2022 and ending September 30, 2023.

**Background**

In accordance with the City Charter, Code of Ordinances, and the laws of the State of Florida, the City Manager calculated a millage rate necessary to fund operating expenditures for the FY 2023 General Fund Budget.

The proposed operating millage rate is \$4.1193 per \$1,000 of taxable value. The total taxable assessed valuation of City property is \$49,271,600,261, which will generate an estimated net tax collection of \$194,845,923. The proposed millage rate along with other revenue resources supports the General Fund operating budget of \$440,278,165.

In addition to the operating millage rate, the proposed combined debt service millage rate is 0.2833 mills. This debt service millage generates revenue to pay for four (4) separate general obligation bond payments.

A debt service millage rate of 0.0228 is proposed for the purpose of paying interest and principal for the City's 2015 General Obligation Refunding Bond and will generate an estimated tax of \$1,068,360 for FY 2023.

A debt service millage rate of 0.0204 is proposed for the purpose of paying interest and principal for the City's 2011A General Obligation Bond and will generate an estimated tax of \$955,901 for FY 2023.

A debt service millage rate of 0.0928 is proposed for the purpose of paying interest and principal for the City's Voter Approved Public Safety Bond and will generate an estimated tax of \$4,348,411 for FY 2023.

A debt service millage rate of 0.1473 is proposed for the purpose of paying interest and principal for the City's Voter Approved Parks Bond and will generate an estimated tax of \$6,902,165 for FY 2023.

The State of Florida's Truth in Millage (TRIM) process requires that taxing authorities calculate a rolled-back rate that applies to the property tax rate as it changes year over year, in relation to property values. The City of Fort Lauderdale's tentative millage rate of 4.1193 results in 9.31% increase over the rolled back rate of 3.7684. The aggregate tentative millage rate for the primary taxing authority of the City of Fort Lauderdale, which includes the dependent district of Sunrise Key, is 4.1230. The current tentative aggregate millage rate is 9.31% above the aggregate rolled-back rate of 3.7717.

### **Resource Impact**

The revenue generated through these taxes will support the FY 2023 budget.
