Recommendation

The City Attorney recommends that the City Commission adopt a Resolution increasing compensation to Special Counsel Haliczer, Pettis & Schwamm, P.A., Nabors, Giblin & Nickerson, P.A., Kim Vaughan Lerner LLP, T.S. Alvarez, P.A., d/b/a Martin, Lister & Alvarez, Billing, Cochran, Lyles, Mauro & Ramsey, P.A., and Johnson, Anselmo, Murdoch, Burke, Piper & Hochman, P.A., for legal services for general liability claims and related litigation and appeals and Haliczer, Pettis & Schwamm, P.A., and Massey, Coican & King, PLLC, for legal services for workers' compensation claim cases.

Background

On May 16, 2017, the City Commission adopted Resolution No. 17-102, appointing Haliczer, Pettis & Schwamm, P.A., Nabors, Giblin & Nickerson, P.A., Kim Vaughan Lerner LLP, and T.S. Alvarez, P.A. d/b/a Martin, Lister & Alvarez, and reappointed Billing, Cochran, Heath, Lyles, Mauro & Anderson, P.A., n/k/a Billing, Cochran, Lyles, Mauro & Ramsey, P.A., as special counsel to represent the City of Fort Lauderdale in connection with general liability claims and related litigation and appeals, at the following hourly rates: \$225.00 for partner level attorneys, \$150.00 for associate attorneys, and \$95.00 for paralegals, plus actual reasonable expenses subject to the City Attorney's approval.

On April 17, 2018, the City Commission adopted Resolution No. 18-69, appointing Johnson, Anselmo, Murdoch, Burke, Piper & Hochman, P.A., as special counsel for general liability claims and related litigation and appeals, at the following hourly rates: \$225.00 for partner level attorneys, \$150.00 for associate attorneys, and \$95.00 for

paralegals, plus actual reasonable expenses subject to the City Attorney's approval.

On February 4, 2020, the City Commission adopted Resolution No. 20-16, appointing Haliczer, Pettis & Schwamm, P.A., and reappointed Massey, Coican & King, PLLC, as special counsel to represent the City of Fort Lauderdale in connection with workers' compensation claim cases, at the following hourly rates: \$225.00 for partner level attorneys, \$150.00 for associate attorneys, and \$95.00 for paralegals, plus actual reasonable expenses subject to the City Attorney's approval; and

The City Attorney's Office has determined that in order to retain the specialized services of the aforementioned counsel in the competitive legal market, it would be appropriate and recommended to increase general liability claims counsel's hourly rates from \$225.00 per hour to \$300.00 per hour for partners, and from \$150.00 per hour to \$225.00 per hour for associates, with paralegals remaining at \$95.00 per hour
