**TITLE**: Motion Approving the Purchase and Installation of Boat Motors – Canamer

Inc. - \$168,887.60 – (Commission Districts 1, 2, 3 and 4)

#### Recommendation

Staff recommends the City Commission approve the one-time purchase and installation of boat motors from Canamer Inc., in the amount of \$168,887.60.

#### **Background**

The Police Department requests that the City Commission approve the purchase and installation of boat motors required to meet its marine operation needs. On July 6, 2022, the Procurement Services Division issued Invitation to Bid (ITB) No. 12714-722. The initial bid opening date was extended from July 29, 2022, to August 8, 2022, to provide additional time for interested bidders to submit a response to the solicitation.

The City received the following bid in response to the solicitation, which was opened on August 9, 2022:

#### 1. Canamer Inc.

The sole bid was reviewed for compliance with the solicitation requirements. Canamer Inc. met all of the solicitation requirements and is deemed a responsive and responsible bidder.

Due to the lack of participation, the Procurement Services Division conducted vendor outreach to the potential bidders who viewed the advertised solicitation but did not respond. Some of the potential bidders indicated it does not sell and/or service marine outboards. Furthermore, market research was conducted, and it revealed that the sole bid is fair and reasonable.

# **Resource Impact**

There will be a fiscal impact to the City in the amount of \$168,887.60 for FY2022.
