Recommendation

Staff recommends the City Commission approve the settlement of the general liability claim in the matter of Marie Rispoli, et al. v. City, Case No. CACE 19-023248 (18) in the amount of \$150,000.

Background

Marie Rispoli filed a general liability claim against the City resulting from an incident on November 6, 2017, where she sustained an injury at George English Park. Ms. Rispoli filed litigation against the City for her injury claim on November 11, 2019. The City Commission reviewed her claim at an Executive Closed Door Session (CAM #22-0878) on September 6, 2022, pursuant to Florida Statutes, Section 286.011(8).

Staff and defense counsel's evaluation of the potential financial exposure to the City determined that a settlement would provide the most cost-effective outcome. Through negotiations, a settlement was reached in the amount of \$150,000, subject to the approval of the City Commission.

Resource Impact

There will be a fiscal impact to the City in the amount of \$150,000.
