TITLE: Motion Approving Proprietary Purchase for the Manufacturing and
Installation of Riverwalk Floating Dock Construction Phase II - Florida Floats
Inc. dba Bellingham Marine - \$422,890 - **(Commission District 2)**

Recommendation

Staff recommends the City Commission approve the proprietary purchase for the manufacture, delivery, and installation of 126 feet of floating dock (126 feet long by 10 feet 4 inches wide) and two American with Disability Act (ADA) compliant access ramps, from Florida Floats Inc. dba Bellingham Marine, in the amount not to exceed \$422,890.

Background

In 2011, the City installed Florida Floats Inc. dba Bellingham Marine (Bellingham Marine) Unifloat® floating docks at four (4) locations along the New River to increase public access for small boats on the Riverwalk. The purpose of this project is to install one (1) additional section of dock and two (2) access ramps between the existing dockage at Esplanade Park to increase downtown waterway access. This project, like the original dock installation project, will be partially funded by the Florida Inland Navigation District (FIND) grant.

Staff recommends using Bellingham Marine's proprietary Unifloat® docks as it is the only way to guarantee the new section will match the freeboard and draft of the existing docks. Furthermore, Bellingham Marine's Unifloat® system uses bars made of Fiber Reinforced Polymer (FRP), instead of steel rebar. By eliminating the steel rebar, this reduces the appearance of spalls within the concrete and minimizes deterioration, therefore extending the life cycle of the dock. Procurement has confirmed Bellingham Marine's pricing, which is based on the length of dockage and includes permitting costs, complies with the procurement requirement for "reasonableness of price".

Resource Impact

There will be a fiscal impact to the City in the amount of \$422,890 for the manufacturing and installation of the floating dock and two access ramps and \$51,000 for in-house project management fees, for a total cost of \$473,890. Funds for this purchase, in the total amount of \$473,890, are available in the FY 2022 – FY 2026 Community Investment

Plan (CIP) in the account(s) listed below.
