That the scheduled October 4, 2022, Conference and Regular Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to October 3, 2022, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on October 3, 2022.

That the scheduled January 3, 2023, Conference and Regular Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to January 4, 2023, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on January 4, 2023.
