- \$175,000 - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve the settlement of the workers' compensation claim in the matter of Marc DeCarlo v. City, Case No. 20-001083MJR in the amount of \$175,000.

Background

Marc DeCarlo, a retired Police Officer, filed a workers' compensation claim for an injury that occurred on July 6, 2010, while in the course and scope of employment with the City, which was accepted as compensable under Chapter 440, Florida Statute. Mr. DeCarlo filed litigation against the City for his injury claim on January 15, 2020.

Staff and defense counsel's evaluation of the potential financial exposure to the City determined that a settlement would provide the most cost-effective outcome. Through negotiations, a settlement was reached in the amount of \$175,000, subject to the approval of the City Commission.

Resource Impact

There will be a fiscal impact to the City in the amount of \$175,000.
