- TITLE: Motion Approving Piggyback Agreement Using Broward County Public Schools Contract FY23-030 with World of Kids Transportation Corp., Franav, LLC. dba Always on the Go, and Maranata School Bus Service Corp., for the Purchase of School Bus Transportation Services - \$330,000 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve the piggyback agreements for the purchase of school bus transportation services from World of Kids Transportation Corp., Franav, LLC. dba Always on the Go, and Maranata School Bus Service Corp. via the Broward County Public Schools Contract FY23-030, effective through June 30, 2025, in the initial fixed and firm contract term amount of \$330,000, and authorize the City Manager to approve two one-year renewal options, in the estimated annual amount of \$110,000 for a potential total contract amount of \$550,000, contingent upon appropriation of funds.

Background

The Parks and Recreation Department provides transportation for youth, teens, and adults enrolled in the City's recreation programs, classes, trips and events. With approximately 1,000 children in summer camp, over 500 CLUB55 members, and year-round youth and teen programming, the City's transportation needs continue to increase. With COVID protocol ending and programming returning to pre-COVID level capacities, transportation is vital component for the participants of these programs.
