TITLE: Motion Accepting a Grant from Florida Department of State, Division of Arts
and Culture - Specific Cultural Project (SCP) Grant - \$25,000
(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a motion accepting a grant from Florida Department of State, Division of Arts and Culture – Specific Cultural Project (SCP) Grant and authorizing the City Manager to enter into an agreement with the Florida Department of State Division of Arts and Culture that will aid in funding the City's Jazz Brunch live performance music series of events.

Background

The City of Fort Lauderdale's Parks and Recreation Department has established strong community partnerships over the last three decades that has allowed the City's Jazz Brunch live performance music series of events to continue to be a success.

The grant provides \$25,000 to fund a specific cultural project, program, exhibition, or series for a period beginning July 1, 2022 and ending June 30, 2023. Funding from this grant will support the City of Fort Lauderdale's Jazz Brunch live performance music series. The downtown Riverwalk area where the event takes place comes alive the first Sunday of each month, creating a dynamic yet cultural atmosphere in the city. The events showcase new and emerging talented local jazz ensembles or artists while enriching our community with sponsored activities and business development.

Resource Impact

This action will result in a positive impact to the City in the amount of \$25,000 with a City Match of \$25,000, which will be appropriated to the accounts below contingent upon the approval of the Consolidated Budget Amendment CAM 22-0894.
