TITLE: Motion Approving Award for Purchase of Communication Maintenance and

Support Services - Econo-Comm Inc. and Tech Tronix Pro - \$260,000 -

(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve agreements, in substantially the forms attached, to purchase of communications maintenance and support services from Econo-Comm Inc. and Tech Tronix Pro, in the initial two (2) year contract term fixed and firm amount of \$260,000; and authorize the City Manager to approve two (2), one-year renewal options in the estimated annual amount of \$130,000, for a potential total contract amount of \$520,000, contingent upon appropriation of funds.

Background

Information Technologies Services is responsible for technical communications support and services of the mission-critical Public Safety Radio System, peripherals, components, and accessories which are utilized by Police, Fire Rescue, and other City departments.

These City departments rely on these services to ensure continuation of critical Public Safety communications services. These services include, but are not limited to, installation, configuration, troubleshooting, and repair of two-way mobile Public Safety radio equipment and components.

On April 11, 2022, the Procurement Services Division issued Invitation to Bid No. 12672-823 - Communication Maintenance and Support Services. On May 10, 2022, the solicitation ended with a total of two (2) bids submitted from two (2) different firms, Econo-Comm, Inc. and Tech Tronix Pro Inc. Neither indicated its status as a Disadvantaged Business Enterprise (DBE).

Econo-Comm, Inc. met the requirements of the bid, and is deemed the low, responsive, and responsible bidder. Staff recommends Commission award the purchase to Econo-Comm, Inc.

Furthermore, pursuant to Section 2.29, <u>Award of Contract</u>, the City reserves the right to award the contract by such combination in the City's best interest. The City is

recommending an alternate award to Tech Tronix Pro to ensure continuity of these mission critical services, if Econo-Comm, Inc. is unable to perform its contractual obligations.

Resource Impact

There will be a fiscal impact in FY23 budget of \$130,000. Future expenditures are contingent upon approval and appropriation of the annual budget.
