TITLE: Resolution Accepting the Affordable Housing Advisory Committee's

(AHAC) 2022 Affordable Housing Incentive Report and Authorizing the Submission to the Florida Housing Finance Corporation- (**Commission**

Districts 1, 2, 3 and 4)

Recommendation

The Affordable Housing Advisory Committee (AHAC) recommends the City Commission adopt a resolution accepting the AHAC's State Housing Initiatives Partnership (SHIP) Program 2022 Affordable Housing Incentive Report and authorize the City Manager to execute all documents associated with the submission of the report to the Florida Housing Finance Corporation (FHFC).

Background

Annually, the AHAC is required to submit an incentive report to FHFC which evaluates the consideration of eleven affordable housing incentives strategies specified in 420.9076 (4) (a)-(k), Florida Statutes.

A public meeting was held on September 12, 2022, where the AHAC approved the Affordable Housing Incentive Strategies report with recommendations. This report is being submitted to the City Commission for acceptance and approval. The public meeting notice and the 2022 Affordable Housing Incentive Report are included as Exhibit 1 and Exhibit 2, respectively.

Resource Impact

There is no fiscal impact to the general fund.
