TITLE: Motion Authorizing Purchase of Reinsurance for Self-Funded Medical Plan

- Cigna Health and Life Insurance Company - \$2,038,374 - (Commission

Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve the purchase of a one-year reinsurance policy with a stop-loss level of \$350,000 for the self-funded medical plan from Cigna Health and Life Insurance Company (Cigna), at a rate of \$87.11 per subscriber, per month, in an estimated total cost of \$2,038,374.

Background

The City of Fort Lauderdale's self-funded medical plan design contemplates a fully insured specific reinsurance policy that covers all incurred medical and pharmacy claims in excess of a designated amount per member per calendar year. This coverage is also known as a specific stop loss policy. These reinsurance policy premiums are only guaranteed for one year at a time and renewals are based on local industry medical cost trends, policy experience, and an insurance company's overall experience in their reinsurance pool.

The City of Fort Lauderdale's current reinsurance policy is underwritten by Cigna and will expire on December 31, 2022. Inasmuch as the competitive solicitation and selection process is inapplicable to the purchase of insurance and insurance-related products pursuant to Subsection 2-176(d), Code of Ordinances of the City of Fort Lauderdale, Florida, the City's contracted consultant, Christian Bergstrom of The Gehring Group, marketed this insurance and finding no real viable quotes, negotiated with the current vendor, Cigna. Cigna offered the same stop loss level as last year, \$350,000, but at an increased premium rate of \$87.11 per subscriber, per month, up from last year's rate of \$62.92. The total estimated premium of \$2,038,374 is based on enrollment of 1,950 and is up from last year's estimated annual amount of \$1,398,334. If the enrollment number increases throughout the Plan Year, the total premium will increase commensurately. This policy is for the period of January 1, 2023, through December 31, 2023. The Insurance Advisory Board reviewed and recommended approval of this item at its September 7, 2022, meeting.

Staff, and by recommendation from the Insurance Advisory Board and the City's Benefits Consultant, requests City Commission approval for the purchase of reinsurance from Cigna Health and Life Insurance Company in the estimated amount of \$2,038,374.
