

JOINT PARTICIPATION AGREEMENT AMENDMENT NUMBER ONE



## WITNESSETH

WHEREAS, on April 15, 2020 the parties entered into a Joint Participation Agreement. hereinafter referred to as the AGREEMENT, wherein the PARTICIPANT agreed to provide pedestrian lighting improvements along State Road SR-A1A in connection with Financial Management (FM) Number 424027-2-58-01 (Funded in Fiscal Year 2019/2020) for the installation of pedestrian lighting on the west side of A1A, from the north end of south beach parking lot to Sunrise Boulevard in Broward County, Florida, hereinafter referred to as the Project; and.

WHEREAS, the parties desire to amend the AGREEMENT; and

WHEREAS, the parties hereto mutually agree that this Amendment is in their best interest;

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations herein, the parties agree to amend the Agreement dated April 15, 2020, as follows:

- The recitals set forth above are true and correct and are deemed incorporated herein. 1.
- Paragraph SIX, page 2 is amended to read as follows: 2.

Except as otherwise set forth herein, this Aggreement shall continue in effect and be binding to both the PARTICIPANT and the DEPARTMENT until the Project is completed as evidenced by the written acceptance of the DEPARTMENT or December 31, 2023, whichever occurs first.

All provisions, covenants, terms and conditions of the AGREEMENT between the parties theretofore entered into of April 15, 2020, as originally set forth therein, which are not hereby expressly amended or modified and not in conflict with the terms hereof, are hereby ratified and confirmed and shall remain the same and be unaffected by these presents.

IN WITNESS WHEREOF, this Agreement is to be executed by the parties below for the purposes specified herein. Authorization has been given to enter into and execute this Agreement by Resolution No. 22.235, hereto attached.
