TITLE: Motion Approving Agreement for the River Oaks Pump Station Project - Ric-

Man Construction Florida, Inc.- \$10,338,284 - (Commission District 4)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the River Oaks Pump Station Project to Ric-Man Construction Florida, Inc., in the amount of \$10,338,284, which include allowances of \$940,000 for FPL utilities, permits, licenses, testing fees, bypass pumps, and undefined conditions.

Background

The purpose of this project is to install two (2) new stormwater pump stations within the River Oaks Preserve. It is intended to collect stormwater from the Edgewood and River Oaks neighborhoods and provide positive discharge into the New River near Interstate 95. The project also includes pavement installation and landscaping restoration.

On July 11, 2022, the Procurement Services Division issued Invitation to Bid No. 12712-123 River Oaks Pump Station Project 12745. The City received five (5) bids in response to the solicitation, which was opened on September 2, 2022. The bids were reviewed for compliance with the bid requirements. Ric-Man Construction Florida, Inc. is the lowest, responsive, and responsible bidder. One (1) of the five (5) vendors that responded has indicated its status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a fiscal impact to the City in the amount of \$10,338,284 for the contract award, with the bid allowances included, and \$500,000 for estimated in-house project management fees for a total project cost of \$10,838,284. Funds for this purchase, in the total amount of \$10,838,284 are available in the FY2023 Community Investment Plan in the accounts listed below.
