A RESOLUTION OF THE CITY COMMISSION OF THE CITY FORT LAUDERDALE, FLORIDA, WAIVING THE COMPETITIVE SOLICITATION AND SELECTION PROCESSES CONTAINED IN THE CITY OF FORT LAUDERDALE PROCUREMENT ORDINANCE FOR PROCURING A 2023 JEEP UNLIMITED JL VEHICLE FROM AUTO FINANCE, INC., AUTHORIZING THF CONVEYANCE OF A 2018 JEEP WRANGLER UNLIMITED IN TRADE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on March 2, 2018, the City purchased from JG Auto Finance, Inc., a 2018 Jeep Wrangler Unlimited vehicle (VIN 1C4BJWDG1JL835735) for use by the City's Police Department for use in community engagement activities, crime prevention, and as a high-water vehicle; and

WHEREAS, the 2018 Jeep Wrangler Unlimited is showing wear and tear; and

WHEREAS, JG Auto Finance, Inc., has offered to take the 2018 Jeep Wrangler Unlimited in equal trade for a new 2023 Jeep Wrangler Unlimited; and

WHEREAS, the value of a new 2023 Jeep Wrangler JL Unlimited is significantly higher than that of the 2018 Jeep Wrangler Unlimited; and

WHEREAS, the acquisition of the 2023 Jeep Wrangler JL Unlimited will not require the expenditure of public funds, with the exception of outfitting and equipping the vehicle as a marked police vehicle; and

WHEREAS, pursuant to Subsection 2-176(e)(17), Code of Ordinances of the City of Fort Lauderdale, Florida, the competitive solicitation and selection processes do not apply to "(p)urchases of goods or services for which the provisions of this article are waived by the city commission by resolution";

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
