Boucher Brothers Beach Management Fort Lauderdale, LLC - 10% of Annual Gross Revenue of Net Sales in Excess of the Minimum Guaranteed Annual Concession Fee in the Sum Total of \$2,928,584 - (Commission

### Recommendation

Staff recommends the City Commission approve a five-year contract, in substantially the form attached, for Beach Equipment Rental Concession with Boucher Brothers Beach Management Fort Lauderdale, LLC (Boucher Bros.), for 10% of annual gross revenue net of sales collected, in excess of the minimum guaranteed annual concession fee in the sum total of \$2,928,584; and authorize the City Manager to exercise one (1) option to renew for an additional five-year period.

#### Background

On October 27, 2022, the Procurement Service Division issued Request for Proposals (RFP) No. 12732-035 for Beach Equipment Rental Concession to provide beach lounge chairs, umbrellas, windbreakers/clamshells, and food and beverage services for visitors of the public beach.

On November 28, 2022, the RFP closed with a total of one firm, the incumbent, Boucher Brothers Beach Management Fort Lauderdale, LLC, submitting a proposal by the due date and time.

On December 6, 2022, the Evaluation Committee (Committee) met to evaluate and rank the sole proposals. On December 9, 2022, the Committee reconvened to score on an additional weighted criterion that was included in the solicitation. Overall, the firm was ranked based on the evaluation criteria shown on the next page.

The Committee recommends approval to award a contract to the sole ranked proposer, Boucher Brothers Beach Management Fort Lauderdale, LLC.

Understanding the scope of the project	15%
Proposed plan for management, staffing and operation of concession. (quality of plan, number of staff available to provide services, etc.)	15%
Experience, qualifications, and references of the proposing firm.	15%
Quality of storage plan, concession area site plan, hurricane preparedness plan with regard to aesthetics, impact on beach and public safety	15%
Availability, diversity and quality of service offered and additional amenities proposed for the public and hotel guests.	10%
