TITLE: Resolution Waiving the Competitive Solicitation and Selection Processes
Contained in the Procurement Ordinance and Approving an Agreement for
Disposal Services for Construction and Demolition Debris with Waste
Management Inc. of Florida - \$563,732 - (**Commission Districts 1, 2, 3
and 4**)

Recommendation

Staff recommends the City Commission adopt a resolution waiving the competitive solicitation and selection process in the Procurement Ordinance and approving an agreement, in substantially the form attached, for Disposal Services for Construction and Demolition Debris (DSCDD) with Waste Management Inc. of Florida (WM) through July 31, 2024, in the estimated amount not to exceed \$563,732.

Background

On August 22, 2017, the Commission approved Invitation to Bid 873-11922 for disposal services for construction and demolition debris (CAM 17-0916). The City renewed this agreement twice and it is currently due to expire on February 14, 2023.

During the negotiations for RFP 12717-835 - Residential Curbside Collection Services (RCCS), the City agreed to extend the DSCDD agreement through the first year of RCCS ending July 31, 2024, and WM agreed to hold pricing for clean fill (dirt and rock) and mixed construction demolition to \$37.50 per ton during this time.

If approved, the purchase is consistent with Section 2-176(e)(17), Code of Ordinances of the City of Fort Lauderdale, where it specifies that the competitive solicitation selection processes do not apply to "purchases of goods or services for which the provisions of this article are waived by the city commission by resolution."

Resource Impact

There is a fiscal impact to the City in the amount of \$250,549. Funding for this purchase is available in the FY 2023 operating budget in the accounts listed below. Future expenditures are contingent upon approval of annual operating budgets.
