TITLE: Second Reading - Ordinance Ratifying and Approving the Transfer of the

Lauderdale Isle Water Management District into the City of Fort

Lauderdale and Providing for the Modification of the District's Charter and

Boundary – (Commission District 4)

Recommendation

Staff recommends the City Commission adopt an ordinance, on Second Reading, ratifying and approving the transfer of the Lauderdale Isle Water Management District into the City and adopting a modified Charter and district boundaries.

Background

The Lauderdale Isle Water Management District (District) is a Dependent Special District established in 1970 through the adoption of a resolution by Broward County Board of County Commissioners pursuant to the Water Resources Act, Chapter 61-1969, Laws of Florida, Special Acts of 1961. The historic core focus of the District has been aquatic weed control and water quality improvement. The City annexed the former Riverland unincorporated area, in which the District was located, in September 2002. Broward County subsequently transferred the District to the jurisdiction of the City of Fort Lauderdale through the adoption of Broward County Resolution 2003-483. While recently addressing a shoreline issue, it was discovered that the southern boundary of the District, as legally described in the Broward County Resolution 2003-483, extends beyond the corporate limits of the City.

Commission Memorandum No: 21-015 on February 23, 2021, had requested to research and correct the boundaries that extend beyond the area annexed into the City from the initial Broward County Resolution (2003-483).

The District presently operates under a charter with provisions that recognize Broward County as the local governing authority. Since the transfer of the district, the City has in practice interpreted all references to the county as being applicable to the city as the local governing authority for the District. The ordinance corrects this by ratifying and approving the transfer of the District and adopting charter amendments, including boundary modifications, determined to be necessary and desirable by the District's governing board and City staff.
