TITLE: Motion Approving Agreement for the Fort Lauderdale Executive Airport

Midfield Run-up Area Expansion - Weekley Asphalt Paving, Inc. -

\$2,384,660 - (Commission District 1)

#### **Recommendation**

Staff recommends the City Commission approve an agreement, in substantially the form attached, with Weekley Asphalt Paving, Inc. (Weekley) for the Fort Lauderdale Executive Airport Midfield Run-up Expansion in the amount of \$2,384,660.

#### **Background**

The Airport Master Plan recommends the expansion of the mid-field run-up area from an existing 54,000 square feet run-up area to approximately 89,000 square feet run- up area, with the addition of jet blast deflectors. The project's scope of work includes survey and geotechnical costs, consultant and design fees, construction inspection and material testing costs, mobilization and demobilization, airfield lighting system, and signage improvements.

On July 11, 2022, the Procurement Services Division issued Invitation to Bid No. 12666-623. The City received three (3) bids in response to the solicitation, which opened on September 15, 2022. The apparent low bidder, Danto Builders (Danto), failed to provide the City with the required three (3) examples of successfully completed projects that are similar in scope and scale, per bid solicitation requirement. This is required for all the bidders to ensure that they have experience with the airfield construction safety and regulation at airports. Additionally, staff also checked the reference that Danto Builders provided and received a negative response regarding Danto's ability to meet work schedules and coordinate with the subcontractors. Based on the above, staff determined that Danto Builders was not qualified to perform airfield construction for this project and deemed non-responsive and non-responsible.

Staff therefore recommends contract award to Weekley, the second low bidder. Weekley has successfully completed the following projects that are similar in scope and scale to the proposed project; Dual Taxilane Access to Taxiway Lima at North Perry Airport (HWO); Taxiway Delta Phase II Reconstruction at Pompano Beach Airpark and Airfield

02/21/2023 CAM #23-0131 Improvements Runway 5-23 at Boca Raton Executive Airport. Weekley has also worked on the FXE Runway 9-27 Rehabilitation project.

The Disadvantaged Business Enterprise Preference is not applicable to this solicitation.

### **Resource Impact**

There is a current fiscal impact to the City in the amount of \$2,384,660 for the contract award and \$41,394 for in-house project management fees for a total cost of \$2,426,054. Funds for this request in the amount of \$2,426,054 are available in the FY 2023 Community Investment Plan in the accounts listed below.
