ISSUE:

The Department of Development Services is requesting a 120-day extension for Circuit Transit Inc., for micro transit shuttle services in an amount not to exceed \$200,000.

The City of Hollywood entered into a final one-year extension of the Agreement on June 1, 2022, with Circuit Transit Inc., to provide shuttle bus services between Downtown Hollywood and Hollywood Beach through March 4, 2023, as approved by Resolution 2022-138.

A 120-day extension is requested for the following reasons:

- (1) Provide the City additional time to evaluate the impact of a Community Shuttle services in the area, especially during peak season.
- (2) Provide time to identify additional service areas and funding for a new contract, and the need to issue a new RFP for a one-year term.

AUTHORITY:

§ 38.49 TERMINATION, EXTENSION AND RENEWAL OF CONTRACTS. (B) Extensions.

The City Manager or designee is authorized to extend for a maximum of 120 days, any contract entered into by the City pursuant to City Commission approval. Any further extensions of such contract require City Commission approval, subject to all requirements of the Procurement Code.
