- TITLE: Resolution Approving Amendments to the Municipal Cemetery System Investment Policy – (Commission Districts 1, 2, 3 and 4)

#### **Recommendation**

Staff recommends that the City Commission adopt a resolution amending the Municipal Cemetery System Investment Policy Statement (IPS) to incorporate changes to the asset allocation of the Cemetery Trust Fund.

### **Background**

The IPS was last revised on January 21, 2021. Florida Statute 218.415 requires local governments to adopt policies for the investment of public funds commensurate with provisions set forth within the statute.

At the Cemetery Board meeting on January 12, 2023, a motion was made that the asset allocation for the Cemetery Trust Fund change to 55% Equity / 45% Fixed Income. While the 55/45 split is consistent within the portfolio guidelines of the IPS, the targets and the benchmark will change. The motion passed unanimously (6-0). (Exhibit 1).

The City's goal is to achieve an equal balance between maintaining purchasing power through principal appreciation of the trust fund and generating income to support the expenditures of the Cemetery System from the Perpetual Care Trust Fund. Investment objectives of the IPS are:

- safety of principal;
- liquidity of funds; and
- return on investment.

#### Resource Impact

There is no current fiscal impact associated with this item. A future positive fiscal impact is expected depending on market conditions.
