- TITLE: Motion Approving a Service Agreement for Sound, Stage & Lighting Services - BFAV, LLC d/b/a All On Stage Productions - (Commission District 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a Service Agreement with BFAV, LLC d/b/a All On Stage Productions,, in substantially the form attached, for Sound, Stage & Lighting Services for an initial one (1) year fixed and firm contract term amount of \$264,650; and authorize the City Manager to execute the Agreement and approve three (3) additional one-year renewal options for an estimated annual renewal amount of \$264,650, for a potential total contract amount of \$1,058,600.

Background

The Parks and Recreation Department is requesting a contract to provide sound, stage and lighting services for City-sponsored events.

On January 12, 2023, the Procurement Services Division issued Invitation to Bid No. 29 for the purposes of establishing rental rate prices on various types of sound and lighting systems, different size stage, video equipment, and technical services to award the contract. The Parks and Recreation Department will rent out the equipment on an as needed basis, contingent upon the size, nature, and budget of the event.

Invitation to Bid No. 29 ended on January 23, 2023, with a total of two (2) bids submitted by the following vendors:

- BFAV, LLC d/b/a All On Stage Productions
- Wasi Entertainment Group

BFAV, LLC d/b/a All On Stage Productions met the requirements of the bid, and is deemed the lowest, responsive, and responsible bidder. Staff recommends that the Commission approve an award of the proposed service contract to BFAV, LLC dba All On Stage Productions.
