- TITLE: Motion Approving a Construction Agreement for Traffic Improvements on NW 18th Court Near Bass Park Sagaris Corp. \$131,000 (Commission District 3)

Recommendation

Staff recommends the City Commission approve a construction agreement, in substantially the form attached, for Traffic Improvements NW 18th Court (Bass Park) with Sagaris Corp. in the amount of \$131,000.

Background

This project is located in the City of Fort Lauderdale on NW 18th Court between NW 26th Terrace and NW 28th Avenue. This project includes milling and resurfacing, landscaping, pavement markings, signage and curbing near and adjacent to the renovated park. The road will be modified by tightening the road, adding parking on the north side with pavement markings, curbing and signing to restrict the two-way traffic on the corridor.

On January 24, 2023, the Procurement Services Division issued an Invitation to Bid (ITB) No. 2212-001. The City received three (3) bids in response to the solicitation, which was opened on February 21, 2023, from the following bidders:

- 1. David Mancini & Sons Inc.
- 2. GPE Engineering & General Contractor Corp.
- 3. Sagaris Corp.

All three bids were reviewed for compliance with the solicitation requirements. Sagaris Corp. met all the solicitation requirements of the ITB and was deemed the low responsive, and responsible bidder.

None of the firms indicated their status as a Disadvantaged Business Enterprise (DBE).

Resource Impact

There is a fiscal impact associated with this action in the amount of \$131,000. Funding is contingent upon the approval of the Consolidated Budget Amendment, CAM 23-0088.
