Re: Determination of Emergency Situation to Conduct Repairs to Fiveash Sludge

Line

On December 20, 2022, the Fiveash Water Treatment Plant experienced a partial blockage of a 12-inch sludge line. Staff has brought in A&A Drainage to assist with tankering the sludge to the wellfield, as well as initiating removal of sections of the pipe and power jetting the line to restore services. The city requires additional assistance to remove sections of pipe to create access points for power jetting the system and has engaged one of our annual contractors, Southern Undergrounding, to assist with these operations.

Due to the time delay in processing a task order given the urgent operational need, at staff's request, the City Manager has declared a procurement emergency, pursuant to Section 2-190(b)(2), of the Code of Ordinance of the City of Fort Lauderdale, Florida. Emergency purchases are permitted in the event of equipment failure, catastrophic damage to City property, or other similar unexpected events. This declaration allows for an immediate response to repair the blocked sludge line, preventing additional damage. Should cost exceed the current bid threshold, a full report of all purchases shall be made to the City Commission at the earliest available Commission Meeting.

The current emergency repair and condition will not impact water production. We will keep you updated with the progress of the repair.

SUBJECT: Determination of Emergency Situation to Conduct Repairs to five-Ash Sludge Line

On December 20, 2022, Five-Ash Water Treatment Plant experienced a partial blockage of a 12" sludge line. We have brought in A&A Drainage to assist with tankering the sludge to the wellfield, as well as initiated removal of sections of the pipe and power jetted the line to restore services. The city needs to bring in Southern Underground to assist in this operation and requests to declare a procurement emergency because of the time delay in processing a task order. The cost of tankering is around \$50,000 a week.

Pursuant to Section 2-190(b)(2), Code of Ordinances of the City of Fort Lauderdale, Florida, emergency purchases are permitted in the event of equipment failure, catastrophic damage to city property, or other similar unexpected event. It is requested that this situation is declared an emergency, allowing immediate response to repair the blocked sludge line. Should cost exceed the current bid threshold, a full report of all purchase shall be made to the City Commission at the earliest available Commission Meeting.
