TITLE: Motion Approving the Purchase of Uniforms - Omega Marketing Group, Inc. - \$479,072 - (**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve the purchase of uniforms from Omega Marketing Group, Inc. for an initial one-year term amount of \$119,768 and authorize the City Manager to approve three (3) one-year renewal options, in the estimated renewal annual amount of \$119,768, for a potential total contract amount of \$479,072, contingent upon appropriation of funds.

Background

On February 3, 2023, the Procurement Services Division issued an Invitation to Bid, Event No. 41, for the purchase of uniforms. The bid was extended as at the time of bid opening there was only one (1) bid. Market outreach was conducted with other vendors who previously showed interest in the Event and had responded to prior bids. However, due to workload and existing obligations, they were unable to place an offer on this Event. The bid provided by Omega Marketing Group, Inc. meets the bid requirements and is deemed the lowest, responsive, and responsible bidder. Omega Marketing Group, Inc. indicated their status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a fiscal impact to the city in the amount of \$119,768. Funds in the amount of \$119,768 are available in the FY 2023 Operating Budget in the accounts listed below. Future expenditures are contingent upon approval and appropriation of the City's operating budgets.
