Streetscape Improvement Project Agreement Authorizing Post Design
Services – Kimley-Horn and Associates, Inc. - \$140,437 - **(Commission
District 2)**

Recommendation

Staff recommends the City Commission approve the Second Amendment to the Professional Services Consultant's Agreement (Contract 636-11169) between Kimley-Horn and Associates, Inc (Kimley-Horn) and City of Fort Lauderdale (City) for the post design services in the amount of \$140,437.

Background

This Project is located on State Road (SR) A1A between the South Beach Parking Lot Entrance (near SE 5th Street) and Sunrise Boulevard, in the City of Fort Lauderdale. The purpose of the Project is to enhance pedestrian lighting and safety and to create a signature hardscape pattern at the intersection of Las Olas Boulevard and SR A1A. The work to be accomplished under the agreement for the Project includes, but is not limited to, landscape, hardscape, site furnishing, and pedestrian lighting improvements.

The City executed the agreement with Kimley-Horn for design services on March 4, 2014 with post design services to be added after design phase completion. The City has engaged a contractor to construct the proposed hardscaping, landscaping, and lighting improvements designed by Kimley-Horn and staff is recommending Kimley-Horn provide construction phase services as Engineer of Record for the duration of the construction phase of this project.

Resource Impact

There will be a fiscal impact to the City of \$140,437 for the second amendment. Funds for this purchase, in the total amount of \$140,437 are available in the FY2023 Community Investment Plan in the accounts listed below.
