These amendments will be made in accordance with the City's Substantial Change Policy as approved by the U.S. Department of housing and Urban Development (HUD). Any changes in assisted activities due to the addition or cancellation of a program, or a change in the purpose, scope, location, or beneficiary of an activity, funding allocation, require an amendment to the Annual Action Plan.
