A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DENYING THE APPLICATION BY RENEE BIRON FOR A WAIVER OF LIMITATIONS FOR THE INSTALLATION OF A SIX (6) POST NO-PROFILE BOAT LIFT PURSUANT TO SECTIONS 47-19(e) OF THE CITY OF FORT LAUDERDALE UNIFIED LAND DEVELOPMENT REGULATIONS ("ULDR"), FOR PROPERTY LOCATED AT RIVA CONDOMINIUM, 1180 N. FEDERAL HIGHWAY, UNIT 1502, SLIP# 7, FORT LAUDERDALE, FLORIDA.

WHEREAS, Section 47-19.3(e) of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR") provides that the City Commission may waive the limitations of Sections 47-19.3(c), and/or 47-19.3(d) under extraordinary circumstances; and

WHEREAS, Renee Biron (hereinafter "Applicant") owns the Property located at Riva Condominium, 1180 N. Federal Highway, Unit# 1502, Slip #7, Fort Lauderdale, Florida, 33304, Property ID# 4942 36 AL 0920 (hereinafter "Property"); and

WHEREAS, Applicant submitted an application for a Waiver of Limitations to allow the installation of a six (6) post no-profile boat lift from the Applicant's Property line into the Middle River and extending a maximum of 41.6'+/- from the Applicant's Property line into the Middle River (hereinafter "Application");

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That each WHEREAS clause set forth above is true and correct and incorporated herein by this reference.

<u>SECTION 2</u>. That the City Commission of the City of Fort Lauderdale, Florida, after reviewing the evidence finds that the Application for a Waiver of Limitations to install a six (6) post no-profile boat lift from the Applicant's Property line into the Middle River and extending a maximum of 41.6'+/- from the Applicant's Property line into the Middle River fails to meet the criteria set forth in ULDR Section 47-19.3 (e) and is therefore hereby denied.
