Recommendation

Staff recommends the Community Redevelopment Agency (CRA) Board of Commissioners approve a transfer of \$3,247,127.98 to the Northwest-Progresso-Flagler Heights (NPF) CRA Incentive Program and Community Investment Plan (CIP) Project account.

Background

On September 8, 2015, the Fort Lauderdale CRA adopted its operating budget and community investment allocations, which included the allocation of \$250,000 to fund the construction of off-street parking improvements. On November 21, 2017, an additional \$2,778,502 was approved to complete the improvements of three CRA-owned properties along Sistrunk Boulevard.

On June 19, 2018, the City Commission approved a resolution to execute an agreement with Florida Power and Light Company (FPL) to prepare a cost estimate and design for the relocation of major transmission lines. On November 16, 2021, the CRA Board approved \$2,197,705.00 to fund the relocation request with a developer contribution of \$207,835.98 for any cost overruns associated with the Utility line relocation, for a net amount of \$1,989,869.02.

The Off-street parking project is complete, and the remaining funds are no longer needed to fulfill the project requirements. An advance deposit of \$2,054,625 was disbursed to FPL on September 12, 2022, for the Sistrunk Phase II Underground Utilities project. The CRA does not anticipate any further obligations during the in-progress project status.

Staff recommends a reappropriation of the remaining funds in both the Off-street parking and Sistrunk Phase II Underground Utilities projects. Reappropriated funds will cover an increase in CRA incentive requests and funding shortages in the NPF Streetscape Improvement Project in fiscal year 2023.

The Redevelopment Program seeks to preserve and expand affordable housing, commercial development, and job opportunities. The NPF CRA Community Redevelopment Plan is designed in part to stimulate private development of areas. The Project is consistent with NPF CRA Plan which provides for direct physical improvements to enhance the overall environment, improve the quality of life, promote public private partnerships, and investment in the area. In addition, per the Future Land Use Plan and CRA Plan, redevelopment and housing opportunities for low, very low, and moderate income household within the Northwest CRA should be encouraged.
