A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A DESIGN REVIEW REIMBURSABLE AGREEMENT AND AUTHORIZING THE CITY MANAGER TO EXECUTE A DESIGN REVIEW REIMBURSABLE AGREEMENT AND ALL AMENDMENTS TO THE DESIGN REVIEW REIMBURSABLE AGREEMENT AND ANY DOCUMENTS ASSOCIATED WITH THE AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION FEDERAL AVIATION ADMINISTRATION; PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Design Review Reimbursable Agreement with the Department of Transportation Federal Aviation Administration ("FAA") is for labor, travel, and expenses required for the FAA to review the City's design package, including drawings, and specifications for the relocation of the Runway 9/27 Localizer Antenna Array and Localizer Shelter at Fort Lauderdale Executive Airport ("FXE"); and

WHEREAS, the Localizer is part of the Instrument Landing System ("ILS"), which provides guidance for landing aircraft; and

WHEREAS, the FAA recommends the relocation of this equipment to further enhance overall safety and efficiency of the Airport and has identified a need for the relocation of the Localizer equipment to prevent or minimize the adverse impacts to the safe and efficient use of navigable airspace; and

WHEREAS, the estimated cost for the FAA's services in the Design Review Reimbursable Agreement is \$51,017.04; and

WHEREAS, City staff intends to apply for a grant to cover the costs of the FAA's services in the Design Review Reimbursable Agreement; and

WHEREAS, the City Commission finds that approving the Design Review Reimbursable Agreement and authorizing the City Manager to execute the Design Review Reimbursable Agreement and all amendments to the Agreement and any documents associated with the Agreement is in the best interest of the City of Fort Lauderdale.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

That the above recitals are true and correct and incorporated into this Resolution SECTION 1. by this reference.

The City Commission of the City of Fort Lauderdale, Florida, hereby approves SECTION 2. the Design Review Reimbursable Agreement with the Department of Transportation Federal Aviation Administration with an estimated cost to the City of \$51,017.04.

SECTION 3. The City Commission hereby authorizes the City Manager to execute the Design Review Reimbursable Agreement and all amendments to the Agreement and any documents associated with the Agreement with the Department of Transportation Federal Aviation Administration.

SECTION 4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. If any clause, section, or other part of this resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this resolution shall not be affected thereby, but shall remain in full force and effect.

SECTION 6. This Resolution shall be in full force and effect upon final passage and adoption.
