**TITLE:** Resolution Approving and Delegating Authority to the Chief Procurement Officer to Execute an Agreement for the Lease Purchase of Life Pak - Stryker Sales, LLC - \$2,042,742.68 - (**Commission Districts 1, 2, 3 and 4**)

**Recommendation**

Staff recommends that the City Commission adopt a resolution approve an agreement for a seven (7)-year lease purchase for LifePak equipment and Lucas batteries with related accessories and services coverage with Stryker Sales, LLC in the amount of \$2,042,742.68:

- Lease equipment total - \$1,415,136.25
- Lease purchase prevent service coverage for seven years - \$627,606.43
- Lease Purchase finance rate - 0.0%

,in substantially the form attached, subject to the review and approval of said agreement, as to form and correctness by the City Attorney or his designee and authorize the Chief Procurement Officer to execute the same.

**Background**

The Lifepak15 defibrillator/monitor allows paramedics to take an electrical image of the heart to determine whether it is functioning properly. If an abnormality is found, the device has the capability to deliver an electric shock that will convert the abnormal rhythm into a normal one.

In addition, the Lifepak15 defibrillator/monitor can measure vital signs such as blood pressure and pulse rates. It is a multi-parameter device combining semi-automated and manual defibrillation with capnography, pulse oximetry, external pacing, 12-lead electrocardiography and other monitoring functions.

The Lucas Chest Compression System is a device that is used to deliver steady and consistent chest compressions in a patient experiencing cardiac arrest. When applied, the Lucas Chest Compression device frees caregivers' hands so they can perform other life-safety interventions. The unit also connects wirelessly to the LifePak15 and provides

post-event reporting on the efficiency of the compressions performed.

Historically, these defibrillators have been part of Fire Rescue’s list of equipment to save lives. In the past, the City Commission approved the following purchases:

- On March 2, 2010, thirteen (13) LUCAS-2 external chest compression (CAR 10-0289, MD-04).
- On January 4, 2011, forty-three (43) replacement LifePak Cardiac Monitors (CAR 10-1741, MD-02).
- On April 5, 2011, four (4) Lucas-2 external chest compression (CAR 11-0476, MD-03).
- On March 20, 2012, two (2) LifePak Cardiac Monitors (CAR 12-0557, PUR-03).

The purpose of this lease agreement is to replace all existing LifePak and Lucas Devices as they have exceeded their useful life.

Pursuant to Section 2-181(f)(5) Code of Ordinances of the City of Fort Lauderdale, Florida, the Chief Procurement Officer has already determined that it is practicable and advantageous to piggyback on the SAVVIK Buying Group Medical Equipment Contract #2021-06. SAVVIK is a cooperative procurement organization created in 1997 as a Minnesota based non-profit corporation serving as a contracting agency for public safety, education and government. It serves over 15,000 agencies participating in all 50 states. Since the Procurement Ordinance, Section 2-176(e)(20) allows for this procurement to proceed without further City Commission action, a Master Agreement has been executed by the Chief Procurement Officer, but a purchase order won’t be issued until this lease purchase and funding, as required, is approved by the City Commission.

**Resource Impact**

This is a seven (7)-year lease agreement. Over the course of the lease agreement, there will be a fiscal impact to the City of \$2,042,742.68. The fiscal year impact for FY2023 will be \$300,000. Each subsequent annual payment will be contingent upon annual appropriation.
