TITLE: Motion Approving an Agreement for Peele Dixie Water Treatment Plant
Variable Frequency Drive Modernization - Graybar Electric Company, Inc.
- \$485,413 - (**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with Graybar Electric Company, Inc., for the purchase and installation of Variable Frequency Drives (VFD) and components for the Peele Dixie Water Treatment Plant (WTP) in the amount of \$485,413.

Background

In January and February 2024, WTP's treatment train #2's and #4's VFD, respectively, faulted and are no longer operational. These VFDs are obsolete, and the manufacturer no longer provides support for the equipment, nor are there replacement parts available on the market for repairs. WTP's treatment building encompasses four (4) treatment trains for producing drinking water for the public and after losing two (2) of the four (4) treatment trains due to faulting VFDs, the plant is now limited to producing half as much drinking water.

WTP has a total of nine (9) VFDs, four (4) in the treatment building, two (2) at the high service pumps, and three (3) at the reject water pumping system. All nine (9) VFDs are original installations when the plant became operational in April 2008. Since all nine (9) VFDs are original, unmodified equipment, and at the "end of their useful life," it is recommended to replace all nine (9) VFDs in the WTP. VFD replacement will be performed in a sequential manner so that overall water production and supply is not affected.

On March 25, 2024, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 274-5. The bid was extended twice and closed on May 3, 2024. The City received three bids and one "no bid" response to the solicitation.

All bids were reviewed for compliance with the solicitation requirements. The bid submitted by Graybar Electric Company, Inc. is deemed the lowest, responsive, and responsible bidder.

None of the firms listed their status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a fiscal impact to the City in the amount of \$485,413. Funds for this purchase are contingent upon approval by the City Commission and appropriation of the Consolidated Budget Amendment CAM 24-0323.
