

**FIRST AMENDMENT TO CITY OF FORT LAUDERDALE FY 2025
GRANT PARTICIPATION AGREEMENT**

This First Amendment (“First Amendment”) to the CITY OF FORT LAUDERDALE FY 2025 Grant Participation Agreement (“Agreement”), is made and entered into this ____ of _____ 2025, by and between:

The City of Fort Lauderdale, a Florida municipality existing under the laws of the State of Florida, whose address is 1 East Broward Blvd., Suite 1320, Fort Lauderdale, FL, 33301, (“City”)

and

Lauderdale Air Show, LLC, a Florida limited liability company, whose address is 5700 N. Harbor City Blvd, Suite 280, Melbourne, FL 32940, (“Applicant”).

WHEREAS, the Applicant is the coordinator and promoter of the Fort Lauderdale Air Show (“Event”) for the benefit of the community and both parties entered into the Agreement on December 4, 2024 to partially fund support services for the Event; and

WHEREAS, the date for the Event has changed from May 10-11, 2025 to May 3-4, 2025; and

WHEREAS, the City and Applicant wish to amend the Agreement to acknowledge the change in the date of the Event.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree to amend this Agreement as follow:

1. The first sentence of Section I.B., Scope of Services, Deliverables is deleted and replaced with the following:

The Participant will coordinate, promote, produce, and host the event held on May 3-4, 2025, as described in City Commission Agenda Memorandum No. 24-0913, as amended by City Commission Agenda Memorandum No. 25-0292 and the Beach Business Improvement District (BBID) Grant Application.

2. Both parties ratify and confirm the terms of the Agreement. All other terms and provisions of the Agreement shall remain in full force and effect, except as specifically amended by this First Amendment.
