

RESOLUTION NO. 25-80

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, VACATING ALL OF THAT CERTAIN SANITARY SEWER EASEMENT RECORDED IN OFFICIAL RECORDS BOOK 3493, PAGE 212, AND BEING A PORTION OF TRACT 1, "LAKE PARK-UNIT 1", ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 23, PAGE 36, ALL OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, LOCATED EAST OF NORTHEAST 18TH AVENUE, NORTH OF EAST SUNRISE BOULEVARD, WEST OF NORTH FEDERAL HIGHWAY (US1) AND SOUTH OF NORTHEAST 13TH STREET, ALL SAID LANDS BEING IN THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA.

WHEREAS, under the provisions of Section 47-24.7 of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR"), 1055 N. Federal Highway, LLC, is applying for the vacation of a sewer easement (Case No. UDP-EV24008) recorded in Official Records Book 3493, Page 212, of the Public Records of Broward County, Florida, more fully described in SECTION 2 below, located east of Northeast 18th Avenue, north of East Sunrise Boulevard, west of North Federal Highway (US1) and south of Northeast 13th Street, Fort Lauderdale, Florida; and

WHEREAS, pursuant to the provisions of the aforementioned Section 47-24.7 of the ULDR, all utilities known to have an interest have been notified and have no objection to the vacation of the easement; and

WHEREAS, the City Engineer has certified that there is no objection to the vacation; and

WHEREAS, the Department of Sustainable Development has made the required reports and has also recommended the vacation of the easement, certifying that the same will not be required to serve the property;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. The City Commission finds that the application for vacation of easement meets the criteria of Section 47-24.7 of the ULDR as enunciated and memorialized in the minutes of its meeting of May 6, 2025.

SECTION 2. That the below-described easement is hereby vacated and shall no longer constitute an easement for sanitary sewers:

ALL OF THAT CERTAIN SANITARY SEWER EASEMENT RECORDED IN OFFICIAL RECORDS BOOK 3493, PAGE 212, AND BEING A PORTION OF TRACT 1, "LAKE PARK-UNIT 1", ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 23, PAGE 36, ALL OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA

More particularly described in Exhibit "A" attached.


Location: East of Northeast 18th Avenue, north of East Sunrise Boulevard, west of North Federal Highway (US1) and south of Northeast 13th Street

SECTION 3. That a copy of this Resolution shall be recorded in the Public Records of Broward County within 30 days from the date of final passage.

SECTION 4. Issuance of a development permit by a municipality does not in any way create any right on the part of an applicant to obtain a permit from a state or federal agency and does not create any liability on the part of the municipality for issuance of the permit if the applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law.


SECTION 5. This approval is conditioned upon the applicant obtaining all other applicable state or federal permits before commencement of the development.

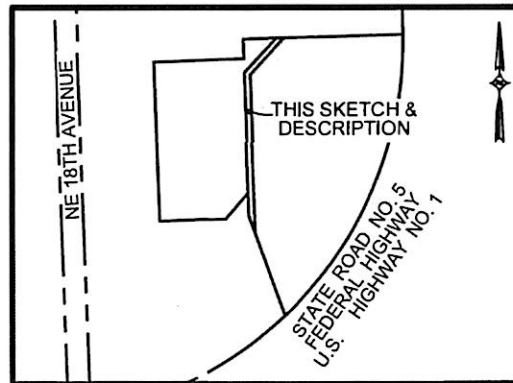
