staff to enhance programs and services offered to our neighbors.

Recommendation

It is recommended that the City Commission approve a resolution to authorize the Parks and Recreation Director to execute agreements for 1) MOU Permit Groups, 2) Program Service Agreement Contracts 3) Facility Use Applications, 4) MOU – CPA, 5) Local Performance Agreements and 6) Swim Instructor Agreements, in substantially the form attached, to be utilized for programs and services that are not directly provided by City staff which enhance programs and services offered to our neighbors.

Background

The City of Fort Lauderdale Parks and Recreation Department communicates with potential instructors, vendors and neighbors on a frequent basis in regards to contractual agreements for programs and services that are not directly provided by City staff.

In an effort to stream line this process and to ensure consistent language is used, the City Attorney's office has reviewed the attached contracts/agreements to be utilized and executed by the Parks and Recreation Director. The contracts/agreements will be the comprehensive standard wording for future agreements with our programming contractors.

The standardized contracts include language that provide specific insurance requirements, integration of like documents for universal usage throughout the department, and stronger language on expectations from vendors and our programming contractors.
