TITLE: Motion to award a one-year contract for tree trimming, site clearing and

maintenance - Invitation to Bid (ITB) 543-11284 - \$91,437.50

Recommendation

It is recommended that the City Commission award a one-year contract for the purchase of tree trimming, site clearing and maintenance to All Florida Tree & Landscape, Inc., utilizing the City's Contract (Form P-0001) in the estimated annual amount of \$91,437.50 and authorize the City Manager to approve three, one-year renewal options, contingent upon appropriation of funds.

Background

The City has received four grants totaling \$135,000 from Broward County for the eradication of invasive non-native vegetation and for replanting with native vegetation. This contract is for the removal of invasive non-native vegetation at Snyder Park, Mills Pond Park, Bill Keith Preserve and other areas that may be deemed necessary by the City.

The Invitation to Bid was opened on October 4, 2013 with two bids received. The low bidder, Royal Regions Incorporation, was unable to provide the required Broward County Class A tree trimmer license (which requires a certified arborist to perform the work of removing invasive non-native vegetation and replanting of native vegetation) and any references that could demonstrate the required experience and therefore has been deemed non-responsive. The second low bidder, All Florida Tree & Landscape, Inc., has met all of the specifications of the bid and has been deemed the single, responsive and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in the amount of \$91,437.50.
